It is a one-time fee of \$50.00 and will be good for future events. It is the vendor's responsibility to contact the South Carolina Department of Revenue at 843-839-2960 to obtain proper forms and information. You can also download the forms and information from www.sctax.org Please call the above number if you have any questions and they will go over the details with you.
- 3. <u>Refunds:</u> Space refunds WILL NOT BE ISSUED FOR ANY REASON for cancellations made LESS THAN 30 days prior to the event.
- 4. <u>Payment for vending spaces:</u> If payment in full is not received by the due date your space will be released and monies forfeited. There is a \$50.00 charge for any returned checks.
