It is a one-time fee of \$50.00 and will be good for future events. It is the vendor's responsibility to contact the South Carolina Department of Revenue at 843-839-2960 to obtain proper forms and information. You can also download the forms and information from www.sctax.org – Please call the above number if you have any questions and they will go over the details with you.

3. **Refunds:** Space refunds WILL NOT BE ISSUED FOR ANY REASON for cancellations made LESS THAN 30 days prior to the event.

4. **Payment for vending spaces:** If payment in full is not received by the due date – your space will be released and monies forfeited. There is a \$50.00 charge for any returned checks.
